## The Object of Rotary

THE OBJECT of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

FIRST. The development of acquaintance as an opportunity for service;

SECOND. High ethical standards of business and professions, the recognition of the worthiness of all useful occupations, and the dignifying of each Rotarian's occupation as an opportunity to serve society;

THIRD. The application of the ideal of service in each Rotarian's personal, business, and community life;

FOURTH. The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional persons united in the ideal of service.

## The Four-Way Test

OF THE THINGS we think, say or do:

- 1) Is it the Truth?
- 2) Is it FAIR to all concerned?
- 3) Will it bring GOODWILL and BETTER FRIENDSHIPS?
- 4) Will it be BENEFICIAL to all concerned?

The ROTARY CODE OF CONDUCT (formerly known as the Declaration of Rotarians in Businesses and Professions) provides a framework for ethical behavior that all Rotarians can use, together with the Four-Way Test, in their business and professional activities.

## Rotary Code of Conduct

AS A ROTARIAN, I will

- 1) EXEMPLIFY the core value of integrity in all behaviors and activities
- 2) USE my vocational experience and talents to serve in Rotary
- 3) CONDUCT all of my personal, business, and professional affairs ethically, encouraging and fostering high ethical standards as an example to others
- 4) BE FAIR in all dealings with others and treat them with the respect due to them as fellow human beings
- 5) PROMOTE recognition and respect for all occupations which are useful to society
- 6) OFFER my vocational talents: to provide opportunities for young people, to work for the relief of the special needs of others, and to improve the quality of life in my community
- 7) HONOR the trust that Rotary and fellow Rotarians provide and not do anything that will bring disfavor or reflect adversely on Rotary of fellow Rotarians.
- 8) NOT SEEK from a fellow Rotarian a privilege or advantage not normally accorded others in business or professional relationship
