



### Trends

The rapid expansion of the United States' senior population is responsible for what has been dubbed a "silver tsunami". In the US, 10,000 baby boomers turn 65 years old each day, a staggering number that will once again force the creation of social systems and structures to support its size. The 2010 census counted 42.3 million Americans age 65 and older. Projections show their numbers more than doubling by 2050.

#### Survey shows most seniors content with lives

Americans are living longer and faring well financially at a time when other age groups are losing ground in the recession. How satisfied people 60 and older say they are:

### **Programs and Services**

#### Advocacy & Protection

**Health Insurance Counseling and Advocacy Program (HICAP)** – Provides unbiased, individualized counseling and group seminars to help Medicare recipients maximize benefits, understand health plan choices and resolve denial of services. COAOC has over 124 HICAP counselors *that LOVE MEDICARE!* 

**Long-term Care Ombudsman Program** – Advocates for the rights of Orange County's older and disabled adults living in skilled nursing and residential care facilities.

**Financial Abuse Specialist Team (FAST)** – Refers individuals to appropriate community resources and educates them about fraud committed by scam artists, caregivers, friends, and family members.

#### Education & Outreach

**Education** – Provides seminars for individuals, corporations (Prepare to Care – 1hour lunch and learn sessions), and CEU training for professionals regarding Medicare, caregiving, long-term care, medication management, and healthy aging.

**SmileMakers Guild** – Mobilizes community support and provides holiday gifts to over 2,700 residents of skilled nursing and residential care facilities.

#### Socialization

**ReConnect Program** – Reintegrates Orange County's isolated adults (age 26+) and older adults into the community, incorporating healthy and meaningful activities into their lives.

**Friendly Visitor Program** – Provides over 4,000 hours annually of companionship and social support to isolated, frail adults.

**Care Management Program** – Develops and monitors individualized care plans for older and dependent adults and their families.

### Outcomes

#### 331,871\* seniors live in Orange County.

We outreach to these seniors in the following ways:

In 2011, our *Senior Guide O.C.* and education programs provided vital information/resources on aging and caregiving to over 85,000 seniors and their families.

Our professional staff and volunteers have provided Medicare presentations to 53,234 seniors and 5,700 one-on-one sessions to Medicare recipients last year – the most in California – saving Orange County residents approximately \$1,987,780.

## Additionally, 122,000 seniors (aged 65+) live alone and are vulnerable to financial and elder abuse.

#### We outreach to these seniors in the following ways:

Our Care Management Program has provided direct, in-home consultations and care management plans to 768 seniors and provided 1,384 hours of caregiver respite, allowing seniors to continue living independently in their own homes and avoiding costly transition into residential care facilities.

88 Friendly Visitor volunteers made 4,200 hours of telephone calls or home visits to isolated seniors last year.

77 certified Ombudsman serve as advocates for 28,000 seniors and disabled adults living in skilled nursing facilities and assisted living homes – each Ombudsman advocates on behalf of approximately 364 seniors.
